

REFERRAL PROGRAM TERMS & CONDITIONS

1. Overview

The UWorld Roger CPA Review Referral Program ("Program") has been created to reward our students ("you," "Referrer," "Member") for recommending us to friends and family who are looking to pass the CPA Exam ("Participants" or "Referred").

The following Referral Program Terms and Conditions contain important information about our program and are considered to be a binding agreement between you and UWorld Roger CPA Review. They will govern your participation in any and all Program offers. By participating in the Program, you agree to the Site Terms and Conditions, the Site Privacy Policy, and the Terms and Conditions set forth in the following document.

2. Eligibility

A qualified referral order occurs when:

- 1. The Referrer, a current customer of UWorld Roger CPA Review, shares their unique purchasing URL with another person, the Referred;
- 2. The Referred then purchases a full, 4-Part, CPA Review package when they arrive at the UWorld Roger CPA Review website by clicking the Referral Program link shared by the Referrer; and
- 3. When the Referred customer's review course has been in effect for 14 days, the Referrer will be approved to receive a \$100 Amazon.com Gift Card emailed to the email address associated with their Roger CPA Review account.
- 4. Gift cards will be sent in batches at any point between the 14-day eligibility date and 60 days post payment by the referred.

To be eligible for participation in the Program, the Referrer must be a current student of UWorld Roger CPA Review. The Referred must purchase a full, four-part CPA Review program. Per-part purchases, Cram Courses, and supplemental products do not count as a qualified referred purchase, unless ordered in addition to a full package course as mentioned above.

Orders through a Direct Bill payment form (or for whom an employer or third-party entity has purchased the course on behalf of the student) do not qualify as referred orders.

Course must be purchased using the custom URL provided to the purchasing entity. If an order is placed not using this URL, credit will not be given to the referring entity.

UWorld Roger CPA Review reserves the right to find ineligible any Participant in the Program at its sole discretion. Current UWorld Roger CPA Review employees are ineligible to participate in the referral program. Participants of other existing compensation programs, including UWorld Roger CPA Review affiliate partners, are ineligible to participate in the referral program. UWorld Roger CPA Review reserves the right, at its sole discretion, to prohibit any person from participating in any aspect of the referral Program.



3. Referral Reward

Upon completion of the 14-day waiting period, any qualified referral order will be accepted and a \$100 Amazon.com Gift Card will be sent by email to the Referrer during the batch period mentioned above. Upon receipt of this email, all responsibility on behalf of the company has been met. Any problems opening, using, spending, or redeeming the gift card must go through Amazon.com.

Rewards may be taxable, depending on the value of the item and the federal, state, and local tax laws applicable to the Participant. Participants are solely responsible for reporting such items on their tax returns and paying any associated tax liability.

Upon receipt of the referral reward, the student order of the Referred is rendered ineligible for any and all discounts, refunds, or any and all retroactive changes to said order.

4. Disclaimer

Participants in the Program must comply with all up-to-date "SPAM" laws. Any distribution of your referral link that could constitute unsolicited commercial email or "spam" under any applicable law or regulation is expressly prohibited and will be grounds for immediate termination of your own course and exclusion from the Referral Program.

UWorld Roger CPA Review reserves the right to cancel or suspend the Program should it determine, in its sole discretion, that the administration, security, or fairness of the Program has been compromised in any way. UWorld Roger CPA Review may cancel, change, suspend, or modify any aspect of the Program or Program Terms and Conditions at any time, without notice. Additionally, UWorld Roger CPA Review may, in its sole and absolute discretion, terminate or suspend any person's participation in the Program for breach of these Program Terms and Conditions or taking any actions that are inconsistent with the intent of these Program Terms and Conditions.
